## Consent Agenda:

- 1. Approval of July 2022 Minutes (Chuck)
- 2. Approval of August 2022 Treasurer's Report (Herb)

KF moved and HK seconded that the consent agenda be approved; it passed unanimously.

## Reports, Discussion, Decisions:

- Leadership Change The discussion of PP's request for a sabbatical of six months (October 1-March 31) from his duties as TfA President showed full support for Paul's request. The consensus was that JS (as Vice President) would prepare meeting agendas and chair the meetings and provide any follow-up as needed. Other board members would pitch-in on specific tasks. PP's absences would not be an issue.
- Trail Maintenance CZ requested more volunteers (and 4WD vehicles) for the August 20<sup>th</sup> workday on N. Taylor Creek Trail. Saturday, September 24 was set as the tentative workday on Rudolph Mountain Trail; it will be the last trail maintenance day for the year.
- 3. S.E.E.K. SS and HK reported that Taurin and Tom Dimler conducted S.E.E.K. For 12-14 children (ranging from 4<sup>th</sup> to 9<sup>th</sup> grades. Jeff Outhier gave a presentation to the group at the Gibson Creek Trailhead. The event concluded with a hike along a portion of the Rainbow Trail from the Gibson Creek Trailhead to the N. Taylor Creek Road and back. SS, HK, Herb's wife (Angie), and some parents assisted. HK suggested that we start planning for next year with Tom & Taurin in the winter during their slower season, offering our support and ideas.
- 4. TfA as a non-profit endorsing a for-profit entity HK said our current working relationship with All the Range is ok, but we need a formal, written agreement. We need to seek legal counsel to draw up an appropriate agreement. JS knows Greg Powell, a Salida attorney, and will contact him. KF will check with Colorado Open



Lands about their arrangement with Pawnee Buttes Seeds. HK will assist. Further information should be available for discussion at the September meeting.

- 5. GOCO Grant Application KF reported that the Youth Corps recommended that we partner with a town; she has had difficulty making contact with the town of Westcliffe. With the August deadline looming it was decided to table this until next year.
- 6. KLZR HK reported that TfA has renewed its sponsorship for another year.
- 7. Google Docs KF has nothing to report at this time, but she should have something for the September meeting.
- 8. Thanksgiving and Celebration of Volunteers It was agreed that we should host an event to thank TfA volunteers for their service. TfA donors should be included. Late October was recommended as the date for this event. JS will check with All Aboard Westcliffe about the availability of their building. SS volunteered to help with the logistics for the event.
- **9.** Valley Strong Dinner It is September 14. JS, KF, and Kate Vickery will check about reserving tables and organizing the potluck meal.
